Over 140 business filings, name reservations, and orders for certificates of status and certified copies of corporations, limited liability companies, and limited partnerships are available online. Failing to file the required statement of information with the Secretary of State can result in penalties from the Franchise Tax Board, suspension, or forfeiture. Additionally, any changes to an entity's information between statutory filing periods must be submitted. Filings such as statements of information, common interest development statements, and publicly traded disclosure statements can be filed online at bizfileOnline.sos.ca.gov. After the initial statement is filed, a schedule can be used to determine the filing period for subsequent statements, which are typically due on or before January 31st and August 31st. Fees range from \$5 to \$40 per submission, depending on the type of document being filed. Surviving entity details can be obtained by requesting a copy of the filed merger document containing its name or an updated status report, which must specify its name for correct retrieval. Further guidance on ordering these documents is provided in Business Entities Records Request. Converted-Out entities are those that have been converted to another type of business entity or to the same type under different jurisdiction as stipulated by law. The new entity's name can be obtained by requesting a copy of the filed conversion document with its name or an updated status report, requiring a specific request for its new name in the latter case. Details on ordering these documents are provided in Business Entities Records Request. Term Expired entities have exceeded their designated period of existence as stated in their Articles of Incorporation. Inactive entities are usually due to their conversion into a federal entity or consolidation with another entity, and the reasons behind this status can be found by requesting an updated status report. Information on how to request these reports is given in Business Entities Records Request.
